## **Release Hold Harmless And Indemnity Agreement**

As an owner, student, contestant, exhibitor, spectator, employee, independent contractor, or parent, I, the undersigned, recognize that all equestrian-related activities may be extremely dangerous, that accidents involving horses and contestants are frequent, that the condition of the land is often hazardous, and that ring or arena footing is rarely perfect. In light of this knowledge, I assume and undertake full responsibility for all risk, inherent in all horse related and livestock related activities, including but not limited to bodily injury and physical harm to horse, rider, and spectator.

In consideration, therefore, for the privilege of riding and/or working around horses and/or livestock or being a spectator or invitee at or on the property (hereinafter referred to as Lake Koocanusa Arena, LLC) the undersigned, with full knowledge, of the potential danger and risks, hereby releases Lake Koocanusa Arena, LLC from any and all responsibility for horse or rider. Losses occasioned by the injury or death of rider, spectator, or horse are agreed to be covered by the undersigned or the insurance of the undersigned and it is further agreed that the undersigned's heirs, representatives, dependents, or guests shall have no right or action against Lake Koocanusa Arena, LLC or its employees, independent contractors, its invitees, or any of Lake Koocanusa Arena, LLC's insurance carriers.

If the person is under 18 years of age, signature of the parent or guardian indicates acceptance of responsibility by said parent or guardian and release of liability of Lake Koocanusa Arena, LLC and affiliated persons.

If damage is caused by or to the undersigned's horse or horses (including, but not limited to, escape from enclosures), the undersigned takes full responsibility for damages to persons, property, or other horses and agrees to indemnify Lake Koocanusa Arena, LLC against liability for such damages.

The undersigned further agrees to indemnify Lake Koocanusa Arena, LLC against and liability for physical loss or injury, or damage causing death, or making destruction necessary to horse or horses in Lake Koocanusa Arena, LLC's care.

It is understood and agreed that Lake Koocanusa Arena, LLC assumes no responsibility for personal property of the horse owner, and said property is stored on the premises at the sole risk of horse owner.

This Indemnity Agreement shall cover all uses of the facilities of Lake Koocanusa Arena, LLC by the Undersigned until revoked in writing by the Undersigned.
